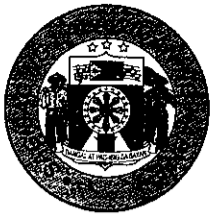
RESOLUTION NO. 584

A RESOLUTION AUTHORIZING HON. JESUS CRISPIN C. REMULLA, PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE KOREA-PHILIPPINES FRIENDSHIP HEALTH PROJECT, TO ENTER INTO AND SIGN THE CONTRACT OF LEASE WITH MR. JOHNSON S. JARDINIANO, REGARDING THE EXTENSION OF PHOTOCOPIING OPERATION IN THE HOSPITAL

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Jesus Crispin C. Remulla, Provincial Governor;

WHEREAS, Section 465 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Provincial Governor, as the Local Chief Executive, shall represent the province in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, the photocopying machine inside the hospital premises will safeguard the rights of the patients to the confidentiality of their medical records, secure proper safekeeping, and avoid lost of medical records;
