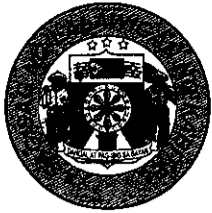
**RESOLUTION NO. 586**

**A RESOLUTION AUTHORIZING HON. JESUS CRISPIN C. REMULLA, PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITE, TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT WITH THE EULOGIO "AMANG" RODRIGUEZ INSTITUTE OF SCIENCE AND TECHNOLOGY-CAVITE CAMPUS REGARDING THE ON-THE-JOB TRAINING OF THE LATTER'S STUDENTS**

**WHEREAS**, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Jesus Crispin C. Remulla, Provincial Governor;

**WHEREAS**, Section 465 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Provincial Governor, as the Local Chief Executive, shall represent the province in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

**WHEREAS**, Section 2(1), Article XIV of the 1987 Philippine Constitution provides that *"the State shall establish, maintain, and support a complete, adequate, and integrated system of education relevant to the needs of the people and society"*;
