RESOLUTION NO. 587

A RESOLUTION AUTHORIZING HON. JESUS CRISPIN C. REMULLA, PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITE, TO PURCHASE A PARCEL OF LAND (8,790 SQUARE METERS) WHICH SHALL BE USED FOR SOCIALIZED HOUSING IN BRGY. BILUSO SILANG, CAVITE

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Jesus Crispin C. Remulla, Provincial Governor;

WHEREAS, Section 465 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Provincial Governor, as the Local Chief Executive, shall represent the province in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, the land to be purchased is 8,790 square meters (Lot 2923-A = 8566 sqm. And Lot 2902-A-1 = 224 sqm.) which is covered by Tax Declaration Nos. 18-0017-06459 and 18-0017-06460, in the amount of One Thousand Three Hundred Pesos (Php1,300.00) per square meter or a total amount of Eleven Million Four Hundred Twenty-Seven Thousand Pesos (Php11,427,000.00);

WHEREAS, said property will be used for the construction of a socialized housing for relocation of informal settlers and/or provision of cost-effective housing for the employees of the Provincial Government in Brgy. Biluso Silang, Cavite;
