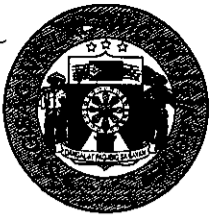
RESOLUTION NO. 597

WHEREAS, Section 34 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that *“local government units shall promote the establishment and operation of people’s organizations, NGOs, and the private sector to become active partners in the pursuit of local autonomy”*;
