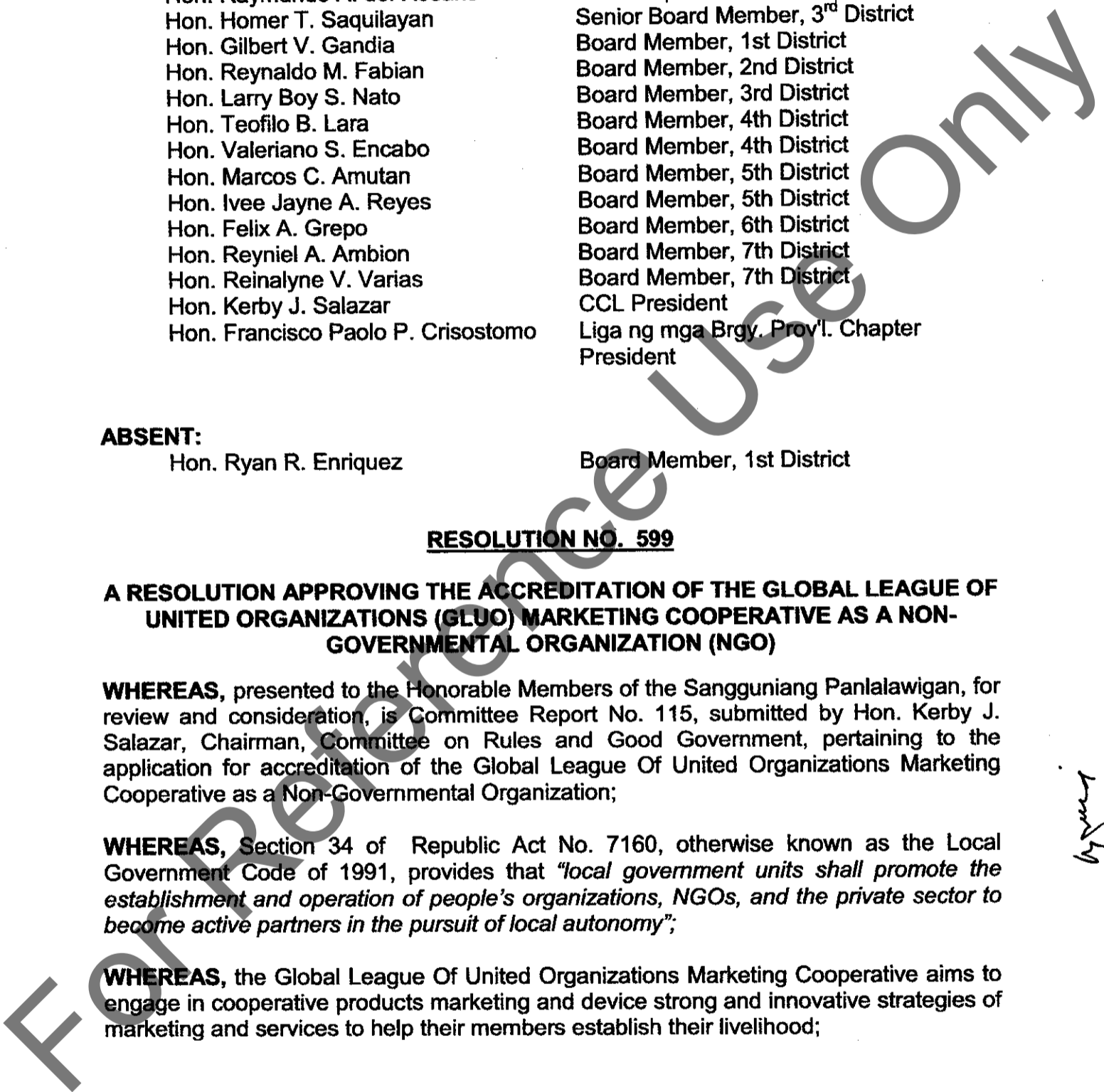
**RESOLUTION NO. 599**
