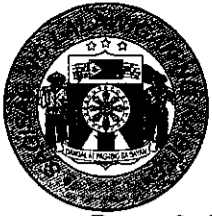

WHEREAS, on the 24th day of June 2008, the Province of Cavite entered into a Joint Venture Agreement with R-II Builders, Inc., a private corporation with principal address at 136 Malakas St., Diliman Quezon City, for the development of a mass housing project at Barangay Pasong Kawayan II, General Trias, Cavite;

WHEREAS, under Article 1, 1.1 of said Joint Venture Agreement, the mass housing project was known as "Pamayanang Maliksi";

WHEREAS, it is the desire of the current provincial government that all housing projects in the Province of Cavite shall be referred to by their generic or general appellation, and not named after specific person/s;

RESOLVED FURTHER, to direct R-II Builders, Inc. to change any signage/s at the said mass housing project which bear/s the title *Pamayanang Maliksi* to *Pamayanan Ng Bagong Kabitenyo* and use the new official designation in all their correspondences;

RESOLVED FINALLY, to direct the provincial Housing Development and Management Office (PHDMO), Department of Education Division of Cavite, R-II Builders, Inc., Homeowners Associations (HOA) of *Pamayanang Maliksi* and all departments and offices of the Provincial Government of Cavite to use the new name *Pamayanan Ng Bagong Kabitenyo* in all their official correspondences.
