A RESOLUTION APPROVING THE REALIGNMENT OF THE UNUTILIZED PORTION OF THE 20% DEVELOPMENT FUND FOR THE YEAR 2014-2016 AMOUNTING TO ONE HUNDRED EIGHTY-TWO MILLION TWO HUNDRED SIXTY THOUSAND FIVE HUNDRED THIRTY-FIVE PESOS AND FIFTY-EIGHT CENTAVOS (PHP182,260,535.58) TO VARIOUS PRIORITY DEVELOPMENT PROJECTS IDENTIFIED IN THE ANNUAL INVESTMENT PROGRAMS OF THE PROVINCE OF CAVITE FOR CALENDAR YEARS 2014-2016

WHEREAS, the needs of Cavite residents with regard to the provision of basic services such as education, livelihood, social welfare programs, and other facilities necessary to promote well-being get bigger, hence, require special attention;

WHEREAS, there is a pressing need to provide adequate infrastructure such as roads, bridges, water systems, health care equipment, and other facilities in order to address the concerns brought about by a developing province faced with widespread migration;

RESOLVED, AS IT IS HEREBY RESOLVED, that the realignment of the unutilized portion of the 20% Development Fund for the Year 2014-2016 amounting to One Hundred Eighty-Two Million Two Hundred Sixty Thousand Five Hundred Thirty-Five Pesos And Fifty-Eight Centavos (Php182,260,535.58) to various priority Development Projects identified in the Annual Investment Programs of the Province of Cavite for Calendar Years 2014-2016, be approved.
