A RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 4 FROM THE CITY OF GENERAL TRIAS, AMOUNTING TO ONE MILLION SIX HUNDRED NINETY THOUSAND PESOS (PHP1,690,000.00)

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is an ordinance from the City of General Trias, entitled:

City Ordinance No. 16-14 (Appropriation) – *Appropriating The Sum Of One Million Six Hundred Ninety Thousand Pesos (P1,690,000.00) To Be Taken From Seminar & Training, Publication & Advertising Expense, And Repair & Maintenance Of Equipment Under The Sangguniang Panlungsod Allocation For The Realignment Of The Office Supplies Expense Of The Said Office And Office Supplies, Gasoline Oil, Lubricant, Repair & Maintenance Of Equipment, And Repair & Maintenance Of Vehicle Allocation For The Realignment Of The Representation Expense Of The Vice Mayor To Be Made Available As Supplemental Budget No. 4*

WHEREAS, upon careful deliberation, it was found that the measure shows substantial compliance with the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and its Implementing Rules and Regulations.
