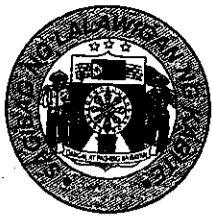
RESOLUTION NO. 613

A RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 3 FROM MUNICIPALITY OF INDANG, AMOUNTING TO ONE MILLION SEVEN THOUSAND PESOS (PHP1,007,000.00)

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is an ordinance from the Municipality of Indang, entitled:

Ordinance No. 162 – Realigning/Reverting The Amount Of One Million Seven Thousand Pesos (P1,007,000.00) Taken From The Savings Of Special Lump Sum Appropriation (Contingency Reserve) And The Savings From The Office Of The Mayor And The Office Of The Sangguniang Bayan (Both Personal Services) To Personal Services, MOOE And Capital Outlay In The Office Of The Mayor; Capital Outlay In The Office Of The Sangguniang Bayan; MOOE Both In The Office Of The Municipal Accountant And Office Of The Municipal Budget Officer; And To MADAC And Scholarship Under Special Lump Sum Appropriation And For Other Purposes (Supplemental Budget No. 3)

WHEREAS, upon careful deliberation, it was found that the measure shows substantial compliance with the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and its Implementing Rules and Regulations. Accordingly, the submitted supplemental budget amounting to Php1,007,000.00 is hereby recommended to be operative in its entirety, effective on the date of its approval;
