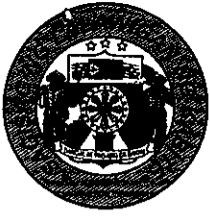
A RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 3 FROM THE MUNICIPALITY OF SILANG, AMOUNTING TO FIFTY-ONE MILLION ONE HUNDRED THOUSAND PESOS (PHP51,100,000.00)

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is Committee Report No. 128, submitted by Hon. Homer T. Saquilayan, Chairman, Committee on Finance, Budget, and Appropriations, pertaining to an ordinance from the Municipality of Silang, entitled:

WHEREAS, upon careful review of the Committee and the Provincial Budget Office, it was found out that the ordinance shows substantial compliance with the provisions of Republic Act No. 7160 and its Implementing Rules and Regulations;
