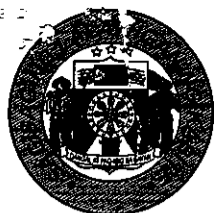
**A RESOLUTION AUTHORIZING HON. JESUS CRISPIN C. REMULLA, PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITE, TO PURCHASE PARCELS OF LAND (1,885 SQUARE METERS) FOR THE CONSTRUCTION OF A MULTI-PURPOSE HALL/COVERED COURT IN BARANGAY MALAKING TATIO, SILANG, CAVITE**

**WHEREAS**, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Jesus Crispin C. Remulla, Provincial Governor;

**WHEREAS**, Section 465 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Provincial Governor, as the Local Chief Executive, shall represent the province in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

**WHEREAS**, the following parcels of land to be purchased has a total size of 1,885 square meters in the amount of One Thousand Pesos (Php1,000.00) per square meter or a total amount of One Million Eight Hundred Fifty-Five Thousand Pesos (Php1,855,000.00);
