**RESOLUTION NO. 180-S-2008**

**WHEREAS**, the Provincial Governor, Hon. Ayong S. Maliksi, sent a letter to this Office informing this august body that the provincial gymnasium has been newly-renovated and is now ready to operate to its full capacity;

**WHEREAS**, the new Ayong S. Maliksi Provincial Gymnasium has the following features:

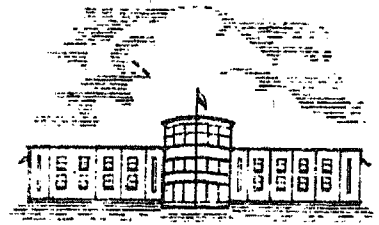
1. Centralized air-conditioning unit
2. One thousand (1,000) seating capacity up to three thousand (3,000) full capacity (including standing)
3. NBA standard CONNOR AGA Neo-shock flooring
4. With ring stand, SAM 45 Folding and movable backstop (2 units)
5. With one unit Multi-Sport Scoreboard
6. With one pair shot clock game clock
7. With complete set of audio system
8. With shower rooms and individual heater
9. With two rooms / players dug-out
10. With VIP lounge
11. With parking area

**WHEREAS**, the new gymnasium is considered as a state-of-the-art structure and has the high standards of a first-class venue, thus, imposition of fees for its utilization is necessary;

**WHEREFORE**, there is a need to enact an ordinance to this effect;

NOW, THEREFORE, be it ordained by the Sangguniang Panlalawigan of Cavite in regular session assembled that:

**PROVINCIAL ORDINANCE NO. 2008-005**

**AN ORDINANCE PRESCRIBING FEES FOR THE UTILIZATION OF THE NEW AYONG S. MALIKSI PROVINCIAL GYMNASIUM**

**SECTION 1.** There is hereby prescribed the following rental fees for the new Ayong S. Maliksi Provincial Gymnasium:

- a) Sports Events and Religious Celebration - P 20,000.00 (for 4 hours only)
- b) Corporate Events, Convention and Private Occasions - P 35,000.00 (for 4 hours only)
- c) Concerts, Musicals, and Variety Shows - P 45,000.00 (for 4 hours only)

**SECTION 2.** There will be an additional charge of P 5,000.00 for every succeeding hour.

**SECTION 3.** The rental fees are inclusive of lights, air-conditions, electricity and dug-outs.

**SECTION 4.** This ordinance takes effect immediately.
