**SECTION 1.** There is hereby created the following positions in the Office of the Sangguniang Panlalawigan:

- a) Two (2) Administrative Aide VI (Audio-Visual Aids Technician I - SG-6), one (1) Bookbinder II (SG-4) and Six (6) Regular Casual in the Office of the Provincial Vice-Governor
- b) Seventeen (17) Executive Assistant I (SG 14) and seventeen (17) Executive Assistant II (SG 17) in the Office of the Provincial Board Members
- c) One Administrative Officer II (SG 15), one (1) Bookbinder II (SG 4) and one (1) Administrative Assistant II (SG 8) in the Office of the Sangguniang Panlalawigan
- d) One (1) Chief Bookbinder (SG 18), one (1) Bookbinder IV (SG 10), one Bookbinder III (SG 7) and one (1) Bookbinder II (SG 4) in the Provincial Library

**SECTION 2.** This ordinance takes effect immediately.
