PROVINCIAL ORDINANCE NO. 2013-004

AN ORDINANCE REVERTING THE POSITION OF ADMINISTRATIVE AIDE VI – CLERK III, ITEM NO. 32, SALARY GRADE 6, IN THE OFFICE OF THE PROVINCIAL GOVERNOR

(Sponsored by: HON. ROLANDO S. REMULLA)

WHEREAS, pursuant to Civil Service Commission Memorandum Circular No. 12, s. 2011 (2) paragraph 2 states that with position titles belonging to the career service, the duties of which do not require the highest degree of trust and confidence as shown in the description of duties and responsibilities but were classified as primarily confidential under MC No. 22, s. 2011 shall be reverted to career service classification;

WHEREAS, the same circular further provides that the co-terminus incumbents may, at the discretion of the appointing authority, however, be reappointed to said reverted position under permanent status if found qualified and subject to compliance with the requirement set forth under existing Civil Service Law and Regulation;

WHEREAS, the reversion of the position would increase efficiency and productivity to the Office of the Provincial Governor;
