**PROVINCIAL ORDINANCE NO. 2013-009**

**AN ORDINANCE REVERTING VARIOUS POSITIONS IN THE OFFICE OF THE PROVINCIAL VICE GOVERNOR AND OFFICE OF THE SANGGUNIANG PANLALAWIGAN**

*(Sponsored by: Hon. Rolando S. Remulla  
 Co-Sponsored By: All Sangguniang Panlalawigan Members)*

**WHEREAS**, pursuant to Civil Service Commission Memorandum Circular No. 12 s. 2012 (2) paragraph 2, positions titles belonging to the career service, the duties of which do not require the highest degree of trust and confidence as shown in the description of duties and responsibilities but were classified as primary confidential under MC No. 22 s. 2007, shall be reverted to the career service classification;

**WHEREAS**, the same circular further provides that the co-terminus incumbents may, at the discretion of the appointing authority, however, be reappointed to said reverted position under permanent status if found qualified and subject to compliance with the requirement set forth under existing Civil Service Law and Regulation;

**WHEREAS**, the reversion of such positions would increase efficiency and productivity to the Office of the Provincial Vice Governor and Office of the Sangguniang Panlalawigan;

**NOW, THEREFORE**, on motion of Hon. Remulla, duly seconded by Hon. Gawaran and all the members present, be it

**RESOLVED, AS IT IS HEREBY RESOLVED** that this ordinance be enacted:

**SECTION 1.** The following positions under the Office of the Provincial Vice Governor shall be reverted to career classification:

- a). Three (3) Administrative Aide VI (Clerk III), SG 6 (VG-10, VG-11 and VG-12);
- b). Three (3) Administrative Aide III (Clerk I) SG 3 (VG-7, VG-6, VG-3);

**SECTION 2.** The following positions under the Office of the Sangguniang Panlalawigan shall be reverted to career classification:

- a) Eleven (11) Local Legislative Staff, III, SG-11 (PS-39, PS-40, PS-43, PS-44, PS-45, PS-48, PS-49, PS-50, PS-51, PS-92, PS-94);
- b). Twelve (12) Administrative Aide VI (Clerk III) SG-6 (PS-55, PS-57, PS-58, PS-59, PS-60, PS-61, PS-62, PS-64, PS-96, PS-97, PS-98, PS-99);
- c). One (1) Administrative Aide III (Clerk 1) SG-6 (PS-65)

**SECTION 3.** This ordinance shall take effect immediately.
