**AN ORDINANCE SEPARATING THE ROAD SAFETY DIVISION FROM THE PROVINCIAL GOVERNMENT-CAVITE OFFICE OF PUBLIC SAFETY (PG-COPS)**

**WHEREAS**, presented to the Honorable Members of the Sangguniang Panlalawigan for review and consideration is the request of Hon. Juanito Victor C. Remulla, Jr., Provincial Governor, for the separation of the Road Safety Division from the Provincial Government-Cavite Office of Public Safety (PG-COPS);

**NOW, THEREFORE**, on motion of Hon. Remulla, duly seconded by Hon. Gawaran and all the members present, be it

**RESOLVED, AS IT IS HEREBY RESOLVED**, that this ordinance be enacted:

**Section 1. Transfer.** The Road Safety Division of the Provincial Government – Cavite Office of Public Safety (PG-COPS) shall be separated from the PG-COPS and shall be transferred to the Office of the Provincial Governor.

**Section 2. Functions.** The Road Safety Division shall continue to perform all its original functions, with the division head reporting to the Provincial Governor.

**Section 3. Separability Clause.** If for any reason or reasons any part or provisions of this ordinance shall be declared to be unconstitutional, unlawful or invalid, other parts or provisions thereof shall not be affected and shall continue to be in full force and effect.

**Section 4. Repealing Clause.** Any Ordinance, resolution, executive order, memorandum, issuances inconsistent with the provision of this ordinance shall be modified or repealed accordingly.

**Section 5. Effectivity Clause.** This ordinance shall take effect after ten (10) days from the posting of its copy at the Provincial Capitol Building and two (2) other conspicuous in the province.
