PROVINCIAL ORDINANCE NO. 2013-012

AN ORDINANCE CONFIRMING THE APPOINTMENT OF MS LOLITA C. PERENA, AS PROVINCIAL DEPARTMENT HEAD (PROVINCIAL AGRICULTURIST), PROVINCIAL GOVERNMENT OF CAVITE

Sponsored by: Hon. Rolando S. Remulla

WHEREAS, submitted for review and consideration of the Honorable Members of this sanggunian is the appointment of Ms. Lolita C. Perena, as Provincial Agriculturist;

WHEREAS, Sec. 482 of the Local Government Code provides for the requirements for the appointment of a Provincial Agriculturist, who shall be a citizen of the Philippines, a resident of the local government concerned, of good moral character, a holder of a collage degree in agriculture or any related course from a recognized college or university, and a first grade civil service eligible or its equivalent and must have practiced the profession in agriculture or acquired experience in a related field for a least five (5) years;

WHEREAS, the Provincial Agriculturist shall take charge of the office for agricultural services, provide technical assistance and support to ensure the delivery of basic services, develop agricultural programs, projects and provisions of adequate facilities relative to agricultural services;

WHEREAS, the appointment of the agriculturist is mandatory for the provincial government;






