PROVINCIAL ORDINANCE NO. 2013-018

AN ORDINANCE AMENDING PROVINCIAL ORDINANCE NO. 2009-002 "CAVITE INVESTMENT INCENTIVES CODE" BY INCORPORATING CHAPTER 2, SEC. 4, DEFINITION OF TERMS, CHAPTER 3, SECTION 6. COMPOSITION OF THE BOARD AND CHAPTER 5, SECTION 17. REGISTRATION OF REQUIREMENTS

WHEREAS, in 2009, the Sangguniang Panlalawigan of Cavite has enacted Provincial Ordinance No. 09-002, otherwise known as the "Cavite Investment Incentives Code";

WHEREAS, this aims to conduct economic activities and strategies that could fast-track the economic development of the province through investment generation and resource mobilization;

WHEREAS, considering the code to have been long running and the Cavite Economic Environment is fastly changing, adaptation of the measure to present condition is deemed indispensable.

NOW, THEREFORE, on motion of Hon. Beratio, duly seconded by Hon. Reyes, Hon. Gawaran and all the Members present, be it ordained as it is hereby ordained by the Sangguniang Panlalawigan in session duly assembled that:

Section 1. Title. This Ordinance shall be known and cited as "An Ordinance Amending Provincial Ordinance No. 2009-002 Cavite Investment Incentives Code by Incorporating Chapter 2, Sec. 4, Definition of Terms, Chapter 3, Section 6. Composition of the Board and Chapter 5. Section 17. Registration of Requirements".

Section 2 Chapter 2, Section 4. Definition of Terms of Provincial Ordinance No. 09-002 is hereby amended to include under item (G) hereof sub-sections 1 and 2 definitions for fiscal and non-fiscal incentives respectively to wit:

G. "Incentives" shall refer to fiscal and non-fiscal incentives as provided for in this Code;

1. *Fiscal incentives* – are annual incentives granted through the recommendation of the Board in terms of monetary values.
2. *Non-fiscal incentives* - refers to the annual incentives other than monetary values that may be enjoyed by a business based on the recommendation of the Board.

Section 3: Chapter 3, Section 6. Composition of the Board, is likewise amended for inclusion in its membership the "Chairman of the SP Committee on Finance, Budget and Appropriations"

Section 4. Chapter 5, Section 17. Registration of Requirements is further amended to include item (a) and (f) as additional documentary requirements for registering enterprises with the Cavite Investment Board, to wit:

- e) Include proof of ownership of sale or lease or any other arrangements of the project site
- f) A copy of feasibility study showing the market, technical, financial and socio-economic viability of the proposed investment.

Section 5. Separability Clause. It is declared that the provisions of this Code are separable, and in the event that one or more provisions are declared illegal or unconstitutional by a competent court, the validity of other provisions shall not be affected, and shall continue to be in force and effect.

Section 6. Effectivity. This ordinance shall take effect after its publication to any newspaper of local circulation once a week for three (3) consecutive weeks.
