PROVINCIAL ORDINANCE NO. 2013-021

AN ORDINANCE AMENDING CERTAIN PROVISIONS OF PROVINCIAL ORDINANCE NO. 007-2012 OTHERWISE KNOWN AS AN ORDINANCE PROHIBITING, REGULATING AND PRESCRIBING CERTAIN USES OF PLASTICS FOR GOODS AND COMMODITIES THAT END UP AS RESIDUAL WASTES AND PROMOTING THE USE OF ECO BAGS AND OTHER ENVIRONMENT FRIENDLY PRACTICES AS AN ALTERNATIVE, AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, in 2012, the Sangguniang Panlalawigan of Cavite has enacted Provincial Ordinance No. 007-2012 entitled *"An Ordinance Prohibiting, Regulating and Prescribing Certain Uses of Plastics for Goods and Commodities that End Up as Residual Wastes and Promoting the Use of Eco Bags and Other Environment Friendly Practices as an Alternative, and Providing Penalties for Violation Thereof."*

WHEREAS, this ordinance aims to minimize if not eliminate activities, products and services that generate residual waste and to promote practices that will support avoidance or reduction of residual waste generation in the province;

WHEREAS, after review from the private sector, particularly the group of people from the plastic industry, it was found out that there were some terms on the ordinance that were mistakenly defined;

WHEREAS, after further study and clarification of the said ordinance and hearing the concerns of plastic industries, amendments of this Ordinance are considered necessary;

NOW, THEREFORE, on motion of Hon. Grepo, duly seconded by Hon. Gawaran and all the Member present, be it

RESOLVED, AS IT IS HEREBY RESOLVED to amend certain provisions of Provincial Ordinance No. 007-2012 to read as follows:

Section 1. Title. This Ordinance shall be known and cited as "AN ORDINANCE AMENDING CERTAIN PROVISIONS OF PROVINCIAL ORDINANCE NO. 007-2012 OTHERWISE KNOWN AS AN ORDINANCE PROHIBITING, REGULATING AND PRESCRIBING CERTAIN USES OF PLASTICS FOR GOODS AND COMMODITIES THAT END UP AS RESIDUAL WASTES AND PROMOTING THE USE OF ECO BAGS AND OTHER ENVIRONMENT FRIENDLY PRACTICES AS AN ALTERNATIVE, AND PROVIDING PENALTIES FOR VIOLATION THEREOF."

Section 2. Polystyrene Plastic definition under Section 4 of the Definition of Terms, is hereby amended to read as:

POLYSTYRENE PLASTIC – a thermostatic resin that is used in a wide variety of application. There are three (3) types:

- a. Polystyrene Paper (PSP)- thermoformed or foamed product such as styrofoam boxes, trays and containers. It is 95% air which makes it very light. Thereby using 5% material input only.
- b. High Impact Polystyrene (HIPS)- an all-in / 100% densed plastic which comes in form of cold drink cups, cutleries and lids. This makes it tough and easily recyclable.
- c. Expandable Polystyrene (EPS)- used 2% material, when heated by steam will mold into form for cushioning products for electronics, appliances as well as insulating boards.

Section 3. Item 3 under Section 5, Prohibited uses of plastic for goods and commodities is hereby amended to read as:

Item 3 – Use of non-reusable and non-recyclable plastic wares for food as container and packaging material such as foam styro boxes and foam products for food and drinks for dine-in and especially for take-out customers.

Section 5. Effectivity. This Ordinance shall take effect after its approval.
