PROVINCIAL ORDINANCE NO. 2013-024

AN ORDINANCE ADOPTING THE PUBLIC-PRIVATE MIX DOTS OF THE DEPARTMENT OF HEALTH AND PHILIPPINE COALITION AGAINST TUBERCULOSIS AND OTHER PRIVATE ORGANIZATIONS TO ADDRESS THE PROBLEM OF TB IN THE PROVINCE OF CAVITE

(Sponsored by: Hon. Irene De Padua Bencito)

WHEREAS, enshrined in the highest law of the land, the Philippine Constitution, Article XII, Section 11, the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other services available to all the people at affordable cost.

WHEREAS, tuberculosis is a major public health problem, as it remains to be the 6th leading cause of illness and the 6th leading cause of death in the country, worldwide the Philippines is the 9th among the 22 high-burdened countries and 2nd in the Western Pacific region with the highest burden of the disease;

WHEREAS, tuberculosis remains as the 8th leading cause of death among Caviterios in Region IV-A, Cavite province has the highest incidence of Multiple Drug Resistant Tuberculosis (MDRTB);

WHEREAS, pursuant to Executive Order No. 187 otherwise known as "Instituting a Comprehensive and Unified Policy (CUP) for the tuberculosis control in the Philippines", the Provincial, Municipal And City Government Of Cavite are among the government agencies working in partnership for a comprehensive and unified policy for the tuberculosis control in the country;

WHEREAS, PPMD is a strategy adopted by the Department of Health (DOH) in partnership with Philippine Coalition against Tuberculosis (PhilCAT) and other private organizations to address the problem of TB in the country by integrating private in NTP (National Tuberculosis Control Program) though referral of TB patients to PPMD:

WHEREAS, according to the 2007 Nationwide TB Prevalence Survey, only 26% of TB symptomatic seeks care from Dots centers. The rest consult private physicians, private and public hospitals and clinics, and others, thus, engaging the private sector was seen as critical strategy to help meet the National target for TB control;

WHEREAS, pursuant to Section 468 of R.A. 7160 also known as the Local Government Code of 1991, the Sangguniang Panlalawigan, as the legislative body of the province shall enact ordinance approved resolutions and approved funds for the general welfare of the Province and its inhabitants;

NOW, THEREFORE, on motion of Hon. Irene P. Bencito, duly seconded by Hon. Edralin G. Gawaran and all the members present, be it ordained by the Sangguniang Panlalawigan in session duly assembled that:

Section 1. Title: An ordinance adopting Public-Private mix DOTS of the Department of Health and Philippine Coalition Against Tuberculosis and other Private Organizations to Address the Problem of Tuberculosis in the Province of Cavite.

Section 2. DECLARATION OF POLICY: It is the policy of Province of Cavite to adopt an integrated and comprehensive program on health, to promote and protect the right to health of every Cavitenos and undertake development and research for the province's health needs and problems.

Section 3. MANDATE AND SCOPE: This Ordinance shall be implemented within the territorial jurisdiction of the province of Cavite with both Public and Private sector adopt Executive Order no.187 otherwise known as Instituting a Comprehensive and Unified policy (CUP) for Tuberculosis control in the Philippines as well as other relevant and applicable laws, rules and regulations issued by the National Government and the Department of Health.

Section 4. DEFINITION OF TERMS

2. DOH shall refer to the Department of Health
2. TB shall refer to Tuberculosis
3. MDRTB shall refer to Multiple Drug Resistant Tuberculosis
4. CUP shall refer to Comprehensive and unified Policy
5. PPMD shall refer to Public-Private mix DOTS
6. PhilCAT shall refer to Philippine Coalition Against Tuberculosis
7. NTP shall refer to National Tuberculosis Control Program
8. DOTS shall refer to Directly Observed Treatment Short-Course

Section 5. IMPLEMENTING GUIDELINES. The Implementing rules and regulations shall be formulated by the Provincial Health Office.

SECTION 6. SEPARABILITY CLAUSE. If for any reason, any section or provision of this ordinance shall be held to be unconstitutional or invalid by competent authority, such judgment or action shall not effect or impair the other sections or provisions thereof.

SECTION 7. REPEALING CLAUSE. All other resolution and ordinance which are inconsistent to this ordinance are hereby repealed or modified accordingly.

SECTION 8. EFFECTIVITY CLAUSE. This ordinance shall take effect after the formulation and approval of the implementing Rules and Regulations.
