AN ORDINANCE DECLARING THE THIRD WEEK OF OCTOBER AS MEAT SAFETY CONSCIOUSNESS WEEK IN THE PROVINCE OF CAVITE

WHEREAS, it is the mandate of the State to protect public health;

WHEREAS, the Consumer Act of the Philippines (RA no. 7394) requires the Department of Agriculture to provide safety and quality standards for Consumer Products related to Agriculture to Assure the Protection of the Public Against Unreasonable risks of injury and hazards to health;

WHEREAS, the celebration is pursuant to Proclamation No. 276 signed by the President Fidel V. Ramos;

WHEREAS, proclamation clearly stated its objective that the public can only be protected from the danger brought by assuming uninspected meat if they are aware of the quality & safety standard of the product.

WHEREAS, the purpose of the social program to orient and educate people regarding food handling meat safety specifically in the proper handling of need meat processing storage, food presentation and even the proper handling and storage of frozen and unfrozen meat and food.

NOW THEREFORE, on motion of Hon. Ives Jayne A Reyes, duly seconded by Hon. Edralin G. Gawaran and all the Members present, be it ordained by the Sangguniang Panlalawigan in session duly assembled that:

Section 1. TITLE. This ordinance shall be known and cited as "An Ordinance Declaring the Third Week of October of Every Year as Meat Safety Consciousness Week in the Province of Cavite".

Section 2. DECLARATION OF POLICY. It is hereby declared that the third week of October of every year as "Meat Safety Consciousness Week in the Province of Cavite" to orient and educate people regarding food handling meat safety specifically in the proper handling of need meat processing storage, food presentation and even the proper handling and storage of frozen and unfrozen meat and food.

Section 3. CELEBRATION. This yearly event shall be celebrated early third week of the month of October.

Section 4. FUNDING. For the effective implementation of this ordinance the Provincial Governor of Cavite shall appropriate necessary fund to defray the expenses of this activity.

Section 5. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.






