**PROVINCIAL ORDINANCE NO. 2013-029**

**AN ORDINANCE DECLARING THE THIRD WEEK OF JUNE OF EVERY YEAR AS "CAVITE PROVINCIAL SAFE KIDS WEEK"**  
*(Sponsored by: Hon. Mark Joseph T. Mupas)*

**WHEREAS**, enshrined with the highest law of the land, the Constitution of the Philippines specifically Article XV, Section 3, paragraph 2, it is the policy of the State to defend the rights of children, that includes special protection from all forms of neglect, abuse, cruelty, exploitation and other prejudicial to their development;

**WHEREAS**, under Presidential Proclamation No. 1307, it is declared every 3<sup>rd</sup> week of June as "NATIONAL *Safe Kids Week*,"

**WHEREAS**, pursuant to that proclamation, traumatic injury is one of the leading causes of mortality and morbidity in Filipino children;

**WHEREAS**, it is the policy of the Province of Cavite to come up with the comprehensive programs for children;

**WHEREAS**, pursuant Section 468 of Local Government Code of 1991 the Sangguniang Panlalawigan shall enact ordinances, pass resolutions, appropriate funds for general welfare of its constituents;

**NOW, THEREFORE**, on motion of Hon. Mark Joseph T. Mupas, duly seconded by Hon. Edralin G. Gawaran and all the Members present, be it ordained by the Sangguniang Panlalawigan in session duly assembled that:

**Section 1. SHORT TITLE** – This Act shall be known as "Cavite Provincial Safe Kids Week".

**Section 2. DECLARATION OF POLICY** – It is hereby declared policy of the state to promote the right of the children's to survival development and special protection with full recognition of the nature of childhood.

**Section 3. OBJECTIVES** – To reinforce the role of parents and other caregivers as the primary caregivers and educators of their children

To enhance and sustain the effort of communities to promote programs and ensure that special support is provided for poor and disadvantaged minority community.

**Section 4. CELEBRATION** – Every third (3<sup>rd</sup>) week of June of every year

**Section 5. IMPLEMENTATION** – The Provincial Government of Cavite shall conduct programs and aligned with the National Theme and shall appropriate funds for the purpose of celebrations.

**Section 6. APPROPRIATIONS** – the amount needed for the implementation of this act shall be appropriated by the Provincial Government of Cavite/Local Government.

**Section 7. SEPERABILITY CLAUSE** – If, for any reason, any portion of this act shall be declared unconstitutional, other parts or provisions hereof which are not affected shall continue to be in force and effect.

**Section 8. EFFECTIVITY CLAUSE** – This Ordinance shall take effect immediately upon approval.
