PROVINCIAL ORDINANCE NO. 2013-030

AN ORDINANCE DECLARING THE MONTH OF OCTOBER OF EVERY YEAR AS CAVITE COOPERATIVE MONTH

(Sponsored by: Hon. Ryan R. Enriquez)

WHEREAS, Article 2 of the Philippine Cooperative Code of 2008 clearly stipulates that it is the policy of the State to foster the creation and growth of cooperatives as a vehicle for promoting self-reliance and harnessing people power towards the attainment of economic development and social justice;

WHEREAS, cooperatives have long played a crucial role in economic development, political empowerment and socio-cultural reform;

WHEREAS, the month of October was declared as National Cooperative Month through Presidential Proclamation No. 493 signed by Pres. Gloria Macapagal-Arroyo;

NOW, THEREFORE, on motion of Hon. Ryan R. Enriquez duly seconded by Hon. Edralin G. Gawan and all the Members present, be it ordained by the Sangguniang Panlalawigan in session duly assembled that:

SECTION I. TITLE. This ordinance shall be known as **"AN ORDINANCE DECLARING THE MONTH OF OCTOBER OF EVERY YEAR AS CAVITE COOPERATIVE MONTH"**.

SECTION II. DECLARATION OF POLICY. It is the policy of the Provincial Government of Cavite to harness the potential of its people in organizing themselves through Cooperatives, to promote self-reliance towards socio-economic development.

SECTION III. CELEBRATION. The month of October of every year is hereby declared as the Cavite Cooperative Month.

SECTION IV. IMPLEMENTATION. The Provincial Government of Cavite through the Provincial Cooperative, Livelihood and Entrepreneurial Office (PCLEDO) shall promote and implement a province-wide celebration every October of every year.

SECTION V. FUNDING. The funding for the implementation of this Ordinance shall come from the yearly appropriation of the Provincial Cooperative, Livelihood and Entrepreneurial Office (PCLEDO).

SECTION VI. EFFECTIVITY. This ordinance shall take effect upon its approval.
