AN ORDINANCE DECLARING THE MONTH OF JUNE OF EVERY YEAR AS CAVITE PROVINCIAL KIDNEY MONTH

(Sponsored by: Hon. Ryan R. Enriquez)

WHEREAS, Article XIII, Section 12 of the 1987 Philippine Constitution provides that the State shall establish and maintain an effective food and drug regulatory system and undertake appropriate health, manpower development, and research, responsive to the country's health needs and problems.

WHEREAS, kidney diseases are one of the leading causes of mortality in the Province of Cavite.

WHEREAS, it is necessary for the Provincial Government to instill consciousness and increase public awareness to its inhabitants of the fatal consequences of kidney diseases;

WHEREAS, the month of June was declared as National Kidney Month through Presidential Proclamation No.184 signed by President Fidel V. Ramos;

NOW, THEREFORE, on motion of Hon. Ryan R. Enriquez duly seconded by Hon. Edralin G. Gawaran and all the Members present, be it ordained by the Sangguniang Panlalawigan in session duly assembled that:

SECTION I. TITLE. This Ordinance shall be known as **"AN ORDINANCE DECLARING THE MONTH OF JUNE OF EVERY YEAR AS CAVITE PROVINCIAL KIDNEY MONTH"**.

SECTION II. PURPOSE. To increase public consciousness and awareness regarding kidney health care.

SECTION III. CELEBRATION. The month of June is hereby declared as the Cavite Provincial Kidney Month.

SECTION IV. IMPLEMENTATION. The Provincial Government of Cavite through the Provincial Health Office shall promote and implement a province-wide celebration every June of every year.

SECTION V. FUNDING. The funding for the implementation of this Ordinance shall come from the yearly appropriation of the Provincial Health Office (PHO).

SECTION VI. EFFECTIVITY. This ordinance shall take effect upon its approval.




