PROVINCIAL ORDINANCE NO. 2013-033

AN ORDINANCE DECLARING JUNE 5 OF EVERY YEAR AS ENVIRONMENT DAY IN THE PROVINCE OF CAVITE

WHEREAS, the celebration of World Environment Day was first declared by the United Nations General Assembly in 1972 to mark the opening of the Stockholm Conference on the Human Environment;

WHEREAS, this proclamation aims to create worldwide awareness of the environmental issues and enable everyone to realize not only their responsibility but also their power to become agents for change in support of sustainable and equitable development;

Section 1. TITLE. "AN ORDINANCE DECLARING JUNE 5 OF EVERY YEAR AS ENVIRONMENT DAY IN THE PROVINCE OF CAVITE".

Section 2. POLICY STATEMENT. It shall be the policy of the Sangguniang Panlalawigan to raise global awareness of the need to make positive environment action.

Section III. CELEBRATION. This yearly event shall be celebrated every 5th of June.

Section IV. FUNDING. For the effective implementation of this ordinance the Provincial Government of Cavite shall appropriate necessary fund to defray the expenses of this activity.

Section V. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.


