**PROVINCIAL ORDINANCE NO. 2013-035**

**AN ORDINANCE DECLARING THE THIRD WEEK OF JULY OF EVERY YEAR AS THE DISABILITY PREVENTION AND REHABILITATION WEEK IN THE PROVINCE OF CAVITE**

**WHEREAS**, Proclamation No. 1870, has been declared in observance of the 3<sup>rd</sup> week of July as the National Disability Prevention and Rehabilitation Week;

**WHEREAS**, July 23 is the birthday of our sublime paralytic, Apolinario Mabini, whose exemplary and dedicated heroic act during the Philippine Revolution has greatly influenced the declaration and observance of the disability prevention and rehabilitation which in effect, has become an outstanding icon for persons with disabilities (PWDs);

**WHEREAS**, Section 2(a) of the Republic Act 7277 provides that the Disabled persons are part of the Philippines Society, thus the Senate shall give support to the improvement of the total well-being of disabled persons and their integration into the mainstream of society. Toward this end, the State shall adopt policies ensuring the rehabilitation, self-development and self-reliance of disabled persons. It shall develop their skills and potentials to enable them to compete favorably for available opportunities.

**WHEREAS**, it is the Provincial interest to stimulate public awareness on the problems of disability, and encourage every citizen to take active responsibility in the upliftment of the economic and social conditions of the PWDs of our society; thereby, encouraging them to take pro-active roles in nation building.

**NOW, THEREFORE**, on motion of Hon. Ives Jayne A. Reyes, duly seconded by Hon. Larry Boy S. Nato and all the Members present, be it ordained by the Sangguniang Panlalawigan in session duly assembled that:

**Section 1 TITLE** This Ordinance shall be known as "An Ordinance Declaring the Disability Prevention and Rehabilitation Week in the Province of Cavite".

**Section 2. DECLARATION OF POLICY.** It is the interest of the Provincial Government to stimulate public awareness on the problems of disability, encourage every citizen to take active responsibility in the upliftment of the economic and social conditions of the PWDs of our society; thereby, encouraging them to take proactive roles in nation building.

**Section 3. CELEBRATION.** This yearly event shall culminate on the birthdate of the sublime paralytic, Apolinario Mabini on July 23 each year, under the auspices of the National Council for the Welfare of Disabled Persons. In the celebration for the week, all public and private welfare agencies are hereby enjoined to participate and cooperate actively in propagating the plight of the PWDs.

**Section 4. FUNDING.** For the effective implementation of this ordinance the Provincial Government of Cavite shall appropriate necessary fund to defray expenses of this activity.

**Section 5. EFFECTIVITY.** This ordinance shall take effect immediately upon its approval.




