PROVINCIAL ORDINANCE NO. 2013-036

AN ORDINANCE DECLARING THE FIRST WEEK OF SEPTEMBER OF EVERY YEAR AS "CAVITE COUNCILORS LEAGUE WEEK"
(Sponsored by: Hon. Mark Joseph T. Mupas)

WHEREAS, the objective of Philippine Councilor's League is to give life, meaning and substance to the constitutional mandate on autonomy and decentralization of power;

WHEREAS, it is the duty of Philippine Councilor's League to promote the development of cooperatives of the country and to uplift the socio economic condition of the people;

WHEREAS, it is the obligation of the Philippine Councilor's League to bring the Government closer to the people;

WHEREAS, it is the duty and obligation of every member to actively participate in activities of the leagues;

WHEREAS, this ordinance is in consonance with Presidential Proclamation No. 212 by then President Fidel V. Ramos dated July 23, 1993, proclaiming every 1st week of September of every year as "Philippine Councilors League Week".

Section 1. SHORT TITLE – This Act shall be known as “CAVITE COUNCILORS LEAGUE WEEK”.

Section 2. DECLARATION OF POLICY – It is hereby declared policy of the State to give life, meaning and substance to the constitutional mandate on autonomy and decentralization of power.

Section 3. OBJECTIVES – To promote the development of cooperatives of the country and to uplift the socio economic condition of the people to bring the Government closer to the people.

Section 4. CELEBRATION – Every First (1st) week of September of every year

Section 5. IMPLEMENTATION – The Provincial Federation and all the members of the Sangguniang Bayan/Panlungsod will spearhead the weeklong activities of the league.

Section 6. APPROPRIATIONS – The amount needed for the implementation of this act shall be appropriated by the Provincial Government of Cavite/Local Government Unit.

Section 7. EFFECTIVITY CLAUSE – This Ordinance shall take effect immediately upon approval.


