PROVINCIAL ORDINANCE NO. 2013-039

AN ORDINANCE DECLARING AUGUST OF EVERY YEAR AS SIGHT SAVING MONTH FOR THE PROVINCE OF CAVITE.

(Sponsored by: Hon. Raul Rex D. Mangubat, Co-Sponsored by: All SP Members)

WHEREAS, Section 16 of the Local Government Code states that all Local Government Units shall exercise the powers necessary and those which are essential to the promotion of the general welfare of its inhabitants;

WHEREAS, month of August was declared as SIGHT SAVING MONTH through the initiative of the Department of Health and the Philippine Academy of Ophthalmology (PAO);

WHEREAS, eye examinations should be part of one's health maintenance and should be taken regardless of age or physical health;

WHEREAS, sight problems leads to enormous human suffering due to the loss of functional ability and self-esteem;

WHEREAS, eye malfunctions has considerable economic implications manifesting as either loss of productivity or loss of income and can lead to social dependency;

WHEREAS, this ordinance shall adopt the provisions of Administrative Order No. 179 s. 2004;

NOW, THEREFORE, on motion of Hon. Raul Rex D. Mangubat, duly seconded by Hon. Edralin G. Gawaran, and all the Members present, be it ordained by the Sangguniang Panlalawigan of Cavite in session duly assembled that:

SECTION 1. TITLE – This Ordinance shall be known as the **"SIGHT SAVING MONTH OF THE PROVINCE OF CAVITE."**

SECTION II. DECLARATION OF POLICY – It shall be declared as the policy of the Provincial Government of Cavite and the different Local Government Units of the Province to declare the month of August and every year thereafter as the Sight Saving Month

SECTION IV – PURPOSE – To increase public awareness on quality eye care and reduce the prevalence of blindness.

SECTION IV – COVERAGE – This ordinance shall cover the whole Province of Cavite.

SECTION V – IMPLEMENTATION - The Provincial and all City and Municipal Health Offices shall be the primary responsible in spearheading the month long activities.

SECTION VI - EFFECTIVITY CLAUSE- This Ordinance shall take effect immediately after its approval.


