AN ORDINANCE DECLARING THE MONTH OF NOVEMBER OF EVERY YEAR AS THE PROVINCIAL RICE AWARENESS MONTH IN THE PROVINCE OF CAVITE

WHEREAS, the government recognizes the role of rice in providing food and in helping alleviate poverty among Filipinos;

WHEREAS, the government aims to attain rice self-sufficiency;

WHEREAS, part of the strategy to attain rice self-sufficiency is intensified information campaign and social marketing to enjoin producers, consumers and policy makers to help achieve the said goal; and

WHEREAS, a sustained and nationwide campaign to boost farmers' morale and motivate them to adopt technologies and further improve farm productivity and encourage the general public to be responsible rice consumers are necessary to complement the government's efforts to achieve rice self-sufficiency;

WHEREAS, the month of November of every year is affirmed as the National Rice Awareness Month pursuant to Proclamation No. 524 signed 2004;

WHEREAS, under Section 468 of Local Government Code of 1991 also known as Republic Act 7160, the Sangguniang Panlalawigan, as the legislative body of the province, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the province and its inhabitants;

WHEREFORE, an ordinance to this effect is necessary;

NOW, THEREFORE, on motion of Hon. Dino Carlo R. Chua duly seconded by Hon. Edralin G. Gawaran and all the Members present be it enacted by the Sangguniang Panlalawigan of Cavite in session duly assembled that:

Section 1. TITLE. This ordinance shall be known and cited as "An Ordinance Declaring the Month of November of Every Year as the Provincial Rice Awareness Month".

Section 2. DECLARATION OF POLICY. It is the policy of the Provincial Government of Cavite to lead the celebration of the Provincial Rice Awareness Month towards achieving rice self-sufficiency and promoting public awareness on responsible rice consumption in the Province of Cavite.

Section 3. CELEBRATION. This yearly event shall be celebrated every month of November.

Section 4. FUNDING. For the effective implementation of this ordinance the Provincial Government of Cavite shall appropriate necessary fund to cover the expenses of this activity.

Section 5. EFFECTIVITY. This Ordinance shall take effect immediately after its approval
