AN ORDINANCE DECLARING THE MONTH OF OCTOBER OF EVERY YEAR AS THE PROVINCIAL STATISTICS MONTH IN THE PROVINCE OF CAVITE

WHEREAS, statistics plays a pivotal and crucial role in policy formulation, planning and decision making in both the government and the private sectors;

WHEREAS, the crucial role of statistics in nation building must be given the official recognition it rightly deserves;

WHEREAS, the celebration is pursuant to Presidential Proclamation No. 647 issued on September 20, 1990 and signed by President Corazon C. Aquino;

WHEREAS, under Section 468 of Local Government Code of 1991 also known as Republic Act 7160, the Sangguniang Panlalawigan, as the legislative body of the province, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the province and its inhabitants;

WHEREFORE, an ordinance to this effect is necessary;

NOW, THEREFORE, on motion of Hon. Dino Carlo R. Chua, duly seconded by Hon. Edralin G. Gawaran and all the Members present be it enacted by the Sangguniang Panlalawigan of Cavite in session duly assembled that:

Section 1. TITLE. This ordinance shall be known and cited as "An Ordinance Declaring the Month of October of Every Year as the Provincial Statistics Month in the Province of Cavite".

Section 2. DECLARATION OF POLICY. It is the policy of the Provincial Government of Cavite to promote greater awareness and appreciation of the importance of statistics to Caviteños and to elicit the cooperation and support of the general public in upgrading the quality and standards of statistics in the Province of Cavite.

Section 3. CELEBRATION. This yearly event shall be celebrated every month of October.

Section 4. FUNDING. For the effective implementation of this ordinance the Provincial Government of Cavite shall appropriate necessary fund to cover the expenses of this activity.

Section 5. EFFECTIVITY. This Ordinance shall take effect immediately after its approval.


