**AN ORDINANCE SUPPORTING AND OBSERVING THE "WORLD POPULATION DAY" IN THE PROVINCE OF CAVITE**

*Sponsored by: Hon. Marcos C. Amutan*

**WHEREAS**, World Population Day is observed on July 11 every year in more than 200 countries, including the Philippines, to raise awareness on global population growth and issues and the importance of living healthy lives.

**WHEREAS**, every year the World Population Day celebration tackles major and sensitive matters which demands global attention.

**WHEREAS**, On this day, business and community organizations as well as reproductive health advocates hold several activities, such as cultural and environment programs, community outreach, essay contests, and counseling on maternal health, human rights, and gender equality, and seminars on health and nutrition.

**WHEREAS**, the Provincial Government of Cavite in recognition of World Population Day supports agencies and nearly 2,100 other organizations in its worldwide initiative in finding solutions to global challenges, including the well-being of the world's population.

**WHEREAS**, through unified and concerted action to resolve population concerns and issues especially within the province of Cavite the Sangguniang Panlalawigan enacted this special Ordinance entitled an Ordinance supporting and observing 'World Population Day' in the Province of Cavite "

NOW THEREFORE, on motion of Hon. Marcus C. Amutan, duly seconded by Hon. Edralin G. Gawaran and all the Members present, be it ordained by the Sangguniang Panlalawigan in session duly assembled that:

**Section 1. Short Title** - This shall be known as "World Population Ordinance".

**Section 2. Policy Statement** - It shall be the policy of the Sangguniang Panlalawigan to take part of the social awareness on global population growth and issues and the importance of living healthy lives. By participating in its yearly celebration and taking part in its activities.

**Section 3. Statement of Purpose** - This Provincial Ordinance shall seek to attain the following objectives:

- a) To contribute significantly more, better and timely information about population-related issues and concerns within the province.
- b) Develop plans and programs that enable governments and private groups to meet the needs of their citizens or constituency, respectively.
- c) To gain insight into the current and future needs of its citizenry and to develop and implement plans to address these growing and shifting needs of the province.
- d) To conduct several activities. Collaborate with schools and universities to reach out to students and out-of-school youths to inform and educate them.

**Section 4. Separability Clause** - Any portion or provision of this Ordinance that may be declared unconstitutional shall not have the effect of nullifying other provisions hereof, as long as such remaining portions can still subsists and can be given effect in their entirety.

**Section 5. Repealing Clause** - All rules and regulations and other issuances or parts thereof, which are inconsistent with the aforesaid ordinance are hereby repealed or modified accordingly.

**Section 6. Effectivity** - This Ordinance shall take effect upon approval.


