**NOW THEREFORE**, on motion of Hon. Eileen R. Beratio, duly seconded by Hon. Edralin G. Gawaran and all the Members present, be it enacted by the Sangguniang Panlalawigan of the province of Cavite in session duly assembled that:

**Section 1. SHORT TITLE.** This ordinance shall be known and cited as "An Ordinance Declaring June 7 of Each Year as Provincial Migrant Workers' Day."

**Section 2. DECLARATION OF POLICY.** It is hereby declared the policy of the Provincial Government to recognize the significant contribution of Filipino migrant workers to the national economy by giving them a special day.

**Section 3. CELEBRATION.** This yearly event shall be celebrated every 7<sup>th</sup> day of June.

**Section 4. INFORMATION CAMPAIGN** - Within thirty (30) days from the approval of this Ordinance, the Provincial Information Office shall conduct an information campaign to apprise the public of the provisions of this ordinance.

**Section 5. SEPARABILITY CLAUSE** - If any portion or provision of this Ordinance is declared void or unconstitutional, the remaining portions thereof shall not be affected thereby and shall remain in full force and effect.

**Section 6. EFFECTIVITY CLAUSE** - This Ordinance shall take effect ten (10) days after its publication in a local newspaper of general circulation in the province and its posting in the Bulletin Board of the Sangguniang Panlalawigan Office and in two (2) other conspicuous places in the province, whichever comes later, either the publication or the posting.
