PROVINCIAL ORDINANCE NO. 2013-051

AN ORDINANCE REQUIRING ALL PUBLIC UTILITY VEHICLES REGULARLY TRAVELLING OVER A ROUTE, TYPICAL FOR COMMERCIAL PURPOSES IN THE PROVINCE OF CAVITE TO PROVIDE TRASH CANS/BINS/BOX INSIDE THE VEHICLE AND PROVIDING PENALTIES FOR VIOLATION THEREOF

WHEREAS, among the problems in Province of Cavite is the indiscriminate dumping/throwing/littering of garbage, refuse, filth and other kinds of solid waste in public places, canals, rivers, drainage and other waste outlets;

WHEREAS, it is the prime duty and responsibility of all the constituents of Province of Cavite to keep their respective environment or surroundings clean and wholesome.

WHEREAS, RA 7160 also known as THE LOCAL GOVERNMENT CODE OF THE PHILIPPINES, SPECIFICALLY ARTICLE III, SECTION 468, mandates the Sangguniang Panlalawigan, as the legislative body of the province, to enact ordinances, approve resolutions and appropriate funds for the general welfare of the province and its inhabitants.

WHEREAS, the Provincial Government of Cavite in its desire to regulate the indiscriminate dumping/littering/throwing of garbage, refuse, filth, and other kinds of solid waste in public places, Sangguniang Panlalawigan in session assembled agreed to enact a regulation and other measures in Province of Cavite.

NOW THEREFORE, on motion of Hon. Mark Joseph T. Mupas, duly seconded by Hon. Edralin G. Gawaran and all the Members present, be it enacted by the Sangguniang Panlalawigan in session duly assembled that:

Section 1- TITLE: This Ordinance shall be known as "An Ordinance Requiring All Public Utility Vehicles Regularly Travelling Over A Route, Typical For Commercial Purposes In The Province Of Cavite To Provide Trash Cans/Bins/Box Inside The Vehicle And Providing Penalties For Violation Thereof".

Section 2 - DECLARATION OF POLICY. It is hereby declared the policy of the Provincial Government to protect our environment, promote cleanliness and enhance the ecological balance for the prevention, control and abatement of environmental pollution.

Section 3 - DEFINITION OF TERMS

- a.) **Public Utility Vehicles-** is a shared passenger transport service which is available for use by the general public.
- b.) **Trash bin/ can-** a container for temporarily storing refuse and waste.
- c.) **Garbage** – unwanted and discarded materials and objects which can be as a solid or liquid and other waste produced daily.

Section 4 - COVERAGE- This ordinance shall cover all public utility vehicles that travel regularly over a route, typically for commercial purposes in the Province of Cavite.

- a.) All public utility vehicles are hereby required to provide/install trash bin inside their vehicle and shall not allow any passenger to throw any garbage in the street either on Terminal or Roads.
- b.) It shall be the duty of the driver and/or conductor of the public utility vehicle to maintain cleanliness of the vehicle.
- c.) The trash can shall regularly empty or have space to provide space to accommodate trash that could have accumulated every travel of the route.
- d.) The Trash can shall Covered and proportionate to the size of the vehicles and passenger capacity.

Section 5 - PENALTY- Any person or persons found guilty of violating any provision of this ordinance shall be penalized by a fine of One Thousand Pesos (1,000.00) or an imprisonment of not less than one (1) month or both such fine and imprisonment at the discretion of the competent court.

Section 6 - IMPLEMENTING RULES AND REGULATIONS - The road safety division, under the Office of the Provincial Governor, shall formulate the implementing guidelines/system of procedure relative, but not limited to the issuance of the Environmental Citation Ticket (apprehension ticket), payment of fines, and others.

The implementing guidelines shall be appended to this Regulation and shall form an integral part thereof.

Section 7 - SEPARABILITY CLAUSE- Any portion of this Regulation which may be declared unconstitutional or invalid by the Court shall not affect or invalidate the other provisions or portions of this ordinance.

Section 8- REPEALING CLAUSE- All ordinances, rules and regulations, or parts thereof, in conflict with, or inconsistent with any provision of their ordinance, are hereby repealed, amended or modified accordingly.

Section 9 - EFFECTIVITY- This ordinance shall take effect after its approval.






