AN ORDINANCE CREATING ONE (1) EXECUTIVE ASSISTANT V POSITION, SALARY GRADE 24, UNDER THE OFFICE OF THE PROVINCIAL GOVERNOR

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Juanito Victor C. Remulla Jr., Provincial Governor, requesting the creation of one (1) Executive Assistant V position, under the Office of the Provincial Governor;

WHEREAS, Article 85 (b) (1) (v) of the Implementing Rules and Regulations of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the Provincial Governor, as the Local Chief Executive, shall appoint all officials and employees whose salaries and wages are wholly or mainly paid out of provincial funds and whose appointments are not otherwise provided in the Code, as well as those he may be authorized by law to appoint;

WHEREAS, the Provincial Budget Office certifies that the creation of the position is within the prescribed budgetary limitation and that the provincial government does not exceed the Personal Services Limitations for Fiscal Year 2014, pursuant to Section 325
