**PROVINCIAL ORDINANCE NO. 079**

**AN ORDINANCE AMENDING SECTION 3F.01 OF PROVINCIAL ORDINANCE NO. 2004-001, OTHERWISE KNOWN AS THE "2004 REVISED REVENUE CODE OF THE PROVINCE OF CAVITE"**

*Sponsored by: Hon. Ives Jayne A. Reyes*

**WHEREAS**, Republic Act (RA) 9640, entitled, "An Act Amending Section 140 (A) of the Republic Act No. 7160, Otherwise Known As "The Local Government Code of 1991", was enacted on May 21, 2009.

**WHEREAS**, as mandated by RA 9640, Section 140 (a) of the Local Government Code of 1991, now states that, "Section 140. Amusement Tax - (a) The province may levy an amusement tax to be collected from the proprietors, lessees, or operators of theatres, cinemas, concert halls, circuses, boxing stadia, and other places of amusement at a rate of not more than ten percent (10%) of the gross receipts from the admission fees";

**WHEREAS**, considering the enactment of RA 9640, which specifically amended the amusement tax rate of not more than thirty percent (30%) of gross receipts from admission fees to a rate of not more than ten percent (10%) which can be levied by provinces, it is deemed proper and necessary to enact an ordinance implementing the said amendment;

**WHEREAS**, Provincial Ordinance No. 2004-001, also known as "The 2004 Revised Revenue Code of the Province of Cavite", was enacted by the Sangguniang Panlalawigan of Cavite on 25 November 2004;

**WHEREFORE**, there is a need to amend this Ordinance to conform with the present requirements;

**NOW THEREFORE**, on motion of Hon. Reyes, duly seconded by Hon. Gawaran and all the members present, be it enacted by the Sangguniang Panlalawigan in session assembled that:

Section 1, Section 3F.01 of Provincial Ordinance No. 2004-001 is hereby amended to read as follows:

**Section 3F.01. Imposition of Tax.** There is hereby levied a tax to be collected from the proprietors, lessees, or operators of theatres, cinemas, concert halls, circuses, boxing stadia, cockpits, and other amusement places to a rate of not more than ten percent (10%) of the gross receipts from admission fees;

**Section 2. Effectivity.** This ordinance takes effect immediately after its approval and publication thereof in local newspaper of general circulation.
