Provincial Ordinance No. 2000-004
 (An Ordinance Implementing Resolution No. 627-S-2000)

AN ORDINANCE CREATING NEW BARANGAY OUT OF BARANGAY SULTAN ESMAEL AND SAN NICOLAS II, BOTH IN THE MUNICIPALITY OF DASMARIÑAS, CAVITE AND SETTING THE DATE OF THEIR PLEBISCITE ON ANY SUNDAY WITHIN THE MONTH OF JANUARY 2001 OR FEBRUARY SHOULD IT BE POSTPONED DUE TO LACK OF MATERIAL, TIME OR FORTUITOUS EVENT

Be it enacted by the Sangguniang Panlalawigan of Cavite, that:

Section I. This ordinance shall be called Dasmariñas Newly Created Barangay 2001;

Section II. There shall be created one (1) New Barangay out of Barangay Sultan Esmael to be named Barangay H-2;

Section III. There shall be created one (1) New Barangay out of Barangay San Nicolas II to be named Barangay Victoria Reyes;

Section IV. The Mother Barangay and the New Barangay created shall have no less than 2000 population or residents;

Section V. The Barangay Officials duly elected on May 1997 shall hold and maintain

Section VI. All laws, rules and regulations governing the creation of new barangays shall become part of this ordinance and shall take preference in case of conflict with other provisions of this ordinance.

Section VII. The new barangays shall respect their boundaries, as they know already the boundaries of the zone created into barangay.

Section VIII. This ordinance shall take effect upon approval.
