**A RESOLUTION AUTHORIZING THE CREATION OF A TRUST FUND FOR PHILHEALTH PAYMENTS TO THE CAVITE CENTER FOR MENTAL HEALTH (CCMH)**

**WHEREAS**, submitted for review and consideration of the Honorable Members of the Sangguniang Panlalawigan is a letter from Hon. Juanito Victor C. Remulla, Jr., Provincial Governor, indorsing the request of Dr. Victoria V. Briguela, Chief of Hospital;

**WHEREAS**, the Chief of Hospital is requesting for the creation of a Trust Fund for Philhealth payments to the Cavite Center for Mental Health (CCMH), from which said healthcare provider shall manage the aforementioned Trust Fund in accordance with the guidelines set by the Philippine Health Insurance Corporation (PHC)

**WHEREAS**, PhilHealth Circular No. 10, s. 2012, Annex C2-Guidelines for registration as Primary Care Benefits Providers, Under I – Documentary requirement no. 5, states that:

*“5. Sanggunian Resolution or Ordinance authorizing the creation of trust fund Philhealth payments to government owned health care providers and reflecting that concerned health care providers shall manage the said trust fund in accordance with the guidelines set by the Corporation. This is optional for initial registration. However, it is mandatory for renewal and reaccreditation”*
