A RESOLUTION ADOPTING THE GLOBAL BUDGET PAYMENT PROGRAM (GBPP) OF THE PHILIPPINE HEALTH INSURANCE CORPORATION AND AUTHORIZING THE PAYMENTS TO BE DEPOSITED IN THE TRUST FUND

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan is a letter from Hon. Juanito Victor C. Remulla, Jr., indorsing the request of Dr. George R. Repique, Jr., Provincial Health Officer I, for the adoption of PhilHealth Global Budget Payment Program arrangement for all public hospital facilities and authorizing payments under the Global Budget payment Program (GBPP) to be deposited in the trust fund;

WHEREAS, PhilHealth Circular No. 037, s. 2012, operationalizes the Global Budget Payment Program (GBPP) to ensure that government health care facilities are fully-equipped to provide the best health services to all PhilHealth member-patients and their dependents;
