**A RESOLUTION RATIFYING THE LOAN AGREEMENT ENTERED INTO BY AND BETWEEN THE PROVINCIAL GOVERNMENT OF CAVITE AND THE LAND BANK OF THE PHILIPPINES**

**WHEREAS**, presented to the Honorable Members of the Sangguniang Panlalawigan, is a letter from Hon. Juanito Victor C. Remulla, Jr., Provincial Governor, requesting for the ratification of the loan agreement entered into by and between the Land Bank of the Philippines (LBP) and the Provincial Government of Cavite;

**WHEREAS**, the agreement pertains to the omnibus term loan facility to finance the construction of (2) two-storey municipal buildings in Indang and General Aguinaldo, Cavite in the amount of One hundred Four Million, Seven Hundred Sixteen Thousand Pesos (Php 104,716,000.00);
