A RESOLUTION AUTHORIZING HON. JUANITO VICTOR C. REMULLA, JR., PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITE, TO ENTER INTO AGREEMENTS WITH VARIOUS ENTITIES

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is Committee Report No. 026-2013, submitted by the Committee on Rules and Good Government Chairman, Hon. Edwin Malvar, regarding the request of Hon. Juanito Victor C. Remulla, Jr., Provincial Governor, for authority, in behalf of the Provincial Government of Cavite, to enter into agreements with various entities:

1. Contract of Lease with Mr. Arnel del Rosario, regarding the lease of the property situated in Lot 7, Block 75, Area D-3, Phase II, DBB, Dasmariñas, City, Cavite for the establishment of a lying-in/emergency clinic.
2. Agreement (Right to Use Road Right of Way) with Emi Jolou Realty Corporation, represented by its President, Jose Vicente E. Jimenez ("Grantor"), regarding the right of way (736 sqm.) for the proposed school building situated at Anabu 2nd, Imus, Cavite.
