A RESOLUTION AUTHORIZING HON. JUANITO VICTOR C. REMULLA, JR., PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITE, TO ENTER INTO AND SIGN A DEED OF ABSOLUTE SALE WITH MS. FLORDELIZA P. NOVELA, FOR THE PURCHASE OF A 18,960 SQUARE METER PARCEL OF LAND LOCATED AT BARANGAY POOK, MAGALLANES, CAVITE, TO BE USED FOR THE ESTABLISHMENT OF A CEMETERY FOR MUSLIM CONSTITUENTS

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan for review and consideration is a letter from Hon. Juanito Victor C. Remulla, Jr., Provincial Governor, requesting for authority to enter into a Deed of Absolute Purchase of a 18,960 square meters in the amount of One Hundred Sixteen Pesos (Php116.00) per square meter located at Barangay Pook, Magallanes, Cavite;

WHEREAS, the property is covered by Transfer Certificate of Title No. 057-20111011059 in the name of Flordeliza P. Novela of Talisay St., Diosomito Subdivision, Naic, Cavite;

WHEREAS, the property is intended for the establishment of a cemetery for the Muslims residing in the province;

RESOLVED, AS IT IS HEREBY RESOLVED, that the Hon. Juanito Victor C. Remulla, Jr., Provincial Governor, be authorized to enter into a Deed of Absolute sale for the purchase of 18,960 square meters in the amount of One Hundred Sixteen Pesos (Php116.00) per square meter located at Barangay Pook, Magallanes, Cavite, for the establishment of a cemetery for our Muslim constituents.
