A RESOLUTION AUTHORIZING HON. JUANITO VICTOR C. REMULLA, JR., PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITE, TO ENROLL IN THE PAYMENT APPLICATION SECURE SYSTEM 5 (PASS 5)

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan for review and consideration is a letter from Hon. Juanito Victor C. Remulla, Jr., Provincial Governor requesting for a resolution authorizing the Provincial Government of Cavite to enroll in the Payment Application Secure System 5 (PASS 5) and further authorizing the Provincial Governor and the Provincial Treasurer, Ms. Josephine D. Daza, to debit the account in relation to the PASS 5 application;

WHEREAS, the Payment Application Secure System 5 (PASS) is an internet-based system which allows importers to submit their Import Entry Declaration (IED) and Import Entry and Internal Revenue Declaration (IEIRD) to the Bureau of Customs (BOC) and pay for the assessed BOC duties and taxes electronically;

WHEREAS, this ePayment Process through PASS 5 is in line with the government move to eliminate graft and corruption and to fast track the importation process;
