WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan for review and consideration is a letter from Mr. Renato A. Abutan, Provincial Administrator, requesting for a resolution authorizing the Provincial Government of Cavite, represented by the Governor, Hon. Juanito Victor C. Remulla Jr., to enter into a Contract of Lease with Mr. Ricardo M. Gonzales, regarding the rental of the latter's residential house located at No. 10 Payapa Road, Galicia 3, Mendez, Cavite

WHEREAS, this undertaking is with regards to the use of latter's residential house as staff house of the University of the Philippines Manila personnel during the operation of the Community Health Development Program in the Province of Cavite;

WHEREAS, the contract shall be for a period of three (3) months commencing from April 1, 2013 and automatically terminating on June 30, 2013 with a monthly rental fee of P.10,000.00;
