RESOLUTION NO. 237-S-2006

AN ORDINANCE GRANTING EXEMPTION TO ANTEL HOLDINGS (GEN. TRIAS), INC. FROM PAYMENT OF TRANSFER TAX

WHEREAS, the Antel Holdings (Gen. Trias), Inc., will be constructing a connecting road and two (2) bridges that will serve as an alternative route to CEPZA, Rosario, from Toclong, Imus, through the Kalayaan Road in San Sebastian, Kawit traversing Ylang Ylang River through Bridge 1 and passing through the present project of Antel Holdings and exiting to Bacao, General Trias through Bridge 2 over Rio Grande River and vice versa;

WHEREAS, relative to said construction, the Antel Holdings has requested for an inventor's incentive, specifically in the form of an exemption from payment of transfer tax;

WHEREAS, after a careful study by the Committee on Ways and Means, such construction which will cost approximately P125 Million and which will be donated eventually to the government, is beneficial to the government since this will provide greater accessibility and convenience to the general public and will open wider opportunities for trade and commerce not only in the nearby municipalities but also to the entire province of Cavite;

WHEREFORE, recognizing the contribution of the private sector in attaining the province's sustainable development, it is necessary that incentives be granted to them,

NOW, THEREFORE, on motion of Hon. Hermogenes C. Arayata III, duly seconded by Hon. Alex L. Advincula, be it ordained by the Sangguniang Panlalawigan Members in Special Session assembled, that:

PROVINCIAL ORDINANCE NO. 2006-03

SECTION 1 – The Antel Holdings (Gen. Trias), Inc. is hereby given exemption from payment of transfer tax.

SECTION 2 – The Provincial Governor is hereby given an authority to enter into a Deed of Donation with Antel Holdings (Gen. Trias), Inc.


SECTION 3 – This Ordinance takes effect after its approval and posting to conspicuous places in the Provincial Capitol.
