RESOLUTION NO. 69-S-2006

**AN ORDINANCE CREATING THE "CAVITE ASSOCIATION OF YOUTH
ORGANIZATIONS (C.A.Y.O.)" AS THE UMBRELLA ORGANIZATION OF ALL
YOUTH ORGANIZATIONS IN THE PROVINCE OF CAVITE**

WHEREAS, in December 2005, the Sangguniang Kabataan Provincial Federation (SKPF) has conducted the first Cavite Youth Parliament as an avenue to unite all active youth in the province;

WHEREAS, during the parliament, the participants, who are also officers of several youth organizations in the province – school, out-of-school, civic and religious youth organizations – had came up with an objective of becoming a partner of the government in the attainment of its developmental goals;

WHEREAS, the participants has forged collaboration and commitment in making themselves as important and useful entities of the society;

WHEREAS, in order to realize their common vision, the participants of the parliament, who are the voice and arm of the organizations they represented, need to form a single organization that would lead in implementing youth programs and projects;

WHEREFORE, an ordinance to this nature shall be enacted;

PROVINCIAL ORDINANCE NO. 2006-02

SECTION 1. There shall be created a "**Cavite Association of Youth Organizations**" also known as **CAYO** in the Province of Cavite.

SECTION 2. The CAYO shall serve as the umbrella unit of all existing youth organizations in the province.

SECTION 3. All youth organizations in the province shall form part of the CAYO and shall be required to apply for accreditation in the CAYO in order to acquire legal personality.

SECTION 4. The CAYO shall have its own officers who will be elected from among the participants of the Cavite Youth Parliament.

SECTION 5. The CAYO shall be mainly responsible in the formulation of policies and strategies necessary in the attainment of the youth's common vision and mission.

SECTION 6. The CAYO shall operate under the direct supervision of the Sangguniang Kabataan Provincial Federation and shall perform its functions in coordination with concerned agencies such as the Provincial Social Welfare and Development Office (PSWDO)

SECTION 7. The CAYO shall have a seat in the Cavite Youth Development Council and shall be a part in the formulation and implementation of the Provincial Youth Development Plan.

SECTION 8. This ordinance takes effect immediately.
