

**CONTRACT**  
**FOR SUPPLY AND DELIVERY OF RAPID ANTIGEN SWAB TEST KIT**

KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT made this 17 1 SEP 2020, by and between:

The **PROVINCIAL GOVERNMENT OF CAVITE**, a local government unit duly organized and existing under the laws of the Philippines herein represented by its **Governor JUANITO VICTOR C. REMULLA**, with postal address at Provincial Capitol Compound, Trece Martires City, hereinafter called the "Entity" of the one part;

and

**MS. DIANE KEITH T. GONZALES**, authorized representative of **DKV Medical Trading**, a company existing under the laws of the Republic of the Philippines with business address at Trece Martires City, Cavite, hereinafter referred to as the "Supplier" of the other part;

WITNESSETH:
