KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT made this 04 SEP 2020, by and between:

The **PROVINCIAL GOVERNMENT OF CAVITE**, a local government unit duly organized and existing under the laws of the Philippines herein represented by its **Governor JUANITO VICTOR C. REMULLA**, with postal address at Provincial Capitol Compound, Trece Martires City, hereinafter called the "Entity" of the one part;

and

MR. EDGARDO C. BOQUIREN, authorized representative of **FGT Electronics Center & Radio Communication Supply**, a company existing under the laws of the Republic of the Philippines with business address at Dasmarinas City, Cavite, hereinafter referred to as the "Supplier" of the other part;

WITNESSETH:


