KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT made this 22 JUN 2020, by and between:

The **PROVINCIAL GOVERNMENT OF CAVITE**, a local government unit duly organized and existing under the laws of the Philippines herein represented by its **Governor JUANITO VICTOR C. 


