KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT made this 15 MAY 2020, by and between:

The **PROVINCIAL GOVERNMENT OF CAVITE**, a local government unit duly organized and existing under the laws of the Philippines herein represented by its Governor **JUANITO VICTOR C. REMULLA**, with postal address at Provincial Capitol Compound, Trece Martires City, hereinafter called the "Entity" of the one part;

and
