KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT made this 24 APR 2020, by and between:

The **PROVINCIAL GOVERNMENT OF CAVITE**, a local government unit duly organized and existing under the laws of the Philippines herein represented by its **Governor JUANITO VICTOR C. REMULLA**, with postal address at Provincial Capitol Compound, Trece Martires City, hereinafter called the "Entity" of the one part;

and

JENNY'S ACY TRADING AND GENERAL MERCHANDISE, a company duly organized and existing under the laws of the Republic of the Philippines with business address at Dasmarias, Cavite, herein represented by **MS. CLARENCE I. GENOVA** hereinafter referred to as the "Supplier" of the other part;


